CITY RENEWS CONTRACT WITH RUMPKKE



Following a round of town-hall meetings and a sealed-bid process, the City of Hurstbourne has renewed its contract with Rumpke for sanitation, yard waste, and recycling services. The Commission wants to thank residents for the feedback received at the town halls in April and May. The information gathered was important in determining what level of service is expected by our residents and we value your input. Going forward, as a next step with these services, we intend to use a survey of residents to hear from more of you on this subject and your feedback will help guide us in future decisions.

Due to the rear-door pickup service Hurstbourne receives, Rumpke was the only bidder for the garbage contract. A five-year contract was offered that included a 63% price increase. After negotiation, the increase was reduced to 56%, for a total cost of \$743,939 per year.

- Garbage pickup remains on Tuesday and Friday.
- Recycling remains on Tuesday.
- Yard waste remains on Friday.

As before, service may be delayed a day during the following holiday weeks:

- New Year's Day
- Memorial Day
- Independence Day
- Labor Day
- Thanksgiving Day
- Christmas Day.

Sanitation and yard-waste services will remain the same. However, to reduce costs, recycling will be converted to an automated pickup by Rumpke.

Starting August 15, recycling became automated using 65-gallon wheeled containers supplied by Rumpke. (Some residents already have the containers.) You will no longer be able to use the small green recycling bins with black lids. There is no need to turn these bins back in. They are yours to keep or dispose of during a pickup. Rumpke delivered the new containers (one per residence) August 9.

Rumpke's truck uses a mechanical arm to hoist and empty the containers. Because of this change, emptied recycling containers will not be returned to the front corner of the house.

Our contract retains garbage pickup at the rear of the house. You may choose to place receptacles at the curb the night before a pickup. If so, Rumpke's employees are expected to return your receptacles to the front corner of the house, along the driveway. The garbage pickup limit for each collection day is three, 30-gallon receptacles or one, 95-gallon receptacle. The 95-gallon container is available from Rumpke for \$3.50 a month, billed to the resident. 95-gallon receptacles must be brought curbside by the homeowner for pickup and will be returned to the front corner of the house.

Place yard-waste at the curb the night before pickup. Residents can pay Rumpke directly for a yard waste receptacle (\$3.50, billed monthly). This is not required. Yard waste can be placed in 20- or 30-gallon containers marked "YARD WASTE" or in compostable bags. "Yard Waste" stickers can be obtained at City Hall free of charge. Tree and shrubbery trimmings should be cut and tied in bundles no more than four feet long and under 50 pounds.

Any color.

CARTONS



Remove caps and straws.

HURSTBOURNE FOURTH OF JULY PARADE

REMINDER – ON STREET PARKING PROHIBITED

The city wants to remind residents that on-street parking is prohibited throughout the City of Hurstbourne. According to Hurstbourne Code of Ordinances, Chapter 72.01(C), "Before on-street parking is permitted, all parking areas on the property must be utilized for parking. Only then may vehicles park on the street, but must abide by all other parking regulations."

Garages and driveways must first be full before on-street parking is allowed. Fines can reach up to \$200 per incident, and cars can be towed if chronic violations occur. Please be respectful of your neighbors and only park on the street when absolutely necessary, and never for long periods of time.

GOOD NEIGHBOR CHECKLIST

We all play a part in being a good neighbor and keeping Hurstbourne a beautiful and welcoming city. Please review the list below to ensure you are doing your part in being a good neighbor.

- PARKING – All vehicles are parked in the garage or driveway *before parking on the street* ✓
 - GARBAGE CANS – Garbage cans are kept at the rear of the garage/driveway for collection ✓
 - PETS – Your dog is leashed, doesn't run free, doesn't bark excessively, and picked up after ✓
 - BUILDING PROJECTS – You inform the City of Hurstbourne **before** you start your project ✓
 - NOISE – Excessive noise levels are kept to a minimum out of respect for your neighbors ✓
 - GRASS AND WEEDS – Your yard is cut, trimmed, and picked up – it's a "*junk-free-zone*" ✓
 - TREES, LEAVES AND DEBRIS – Your trees, leaves, and debris are properly maintained ✓
 - HOME EXTERIOR – Paint, brick, shutters, gutters, steps, driveway are kept up to date ✓
 - PUBLIC SAFETY – Your home and vehicles are locked and you keep a watch on your street ✓
 - CITY STREETS – You carefully share streets with other vehicles, walkers, and bicyclists ✓

REACH ALERT – SCAN THE QR CODE TO SIGN UP



The City of Hurstbourne contracts with REACH Alert, a local company and provider of an instant mass communication system, which enables the City to communicate essential information to our residents in real time. It is a simple, no cost service available to you. You can either scan the QR code to the left to be taken to the sign-up page, or all you have to do is let us know how you would like to receive your REACH Alert messages – whether by text, by email, by telephone, or in all three formats.

Over 1,000 Hurstbourne households have already signed up. Customary Reach Alert messages include sanitation service delays, junk pickup information, picnic events, the City-wide shredding event, yard sales, and weather-related warnings.

After you register, you can login at any time to update your contact information. Anyone in your house can sign up to receive the information. You also have the option of adding up to a total of four email addresses and/or phone numbers to receive alerts. It is important to note that your contact information is held in strict confidence and will not be shared with anyone.

The REACH Alert system is used solely for important and timely messages as determined by City Hall staff.

STREET RESURFACING UNDERWAY



After the bidding process was complete, Libs Paving was awarded the contract for resurfacing services. Work will begin August 24th and should be completed by September 1, weather permitting.

TREE CANOPY CAMPAIGN SCHEDULED FOR FALL

To offset the loss of Hurstbourne's aging tree canopy, the city will again implement the Tree Canopy Program this fall. The city will order up to 50 trees for participating residents to plant in their front yards. Residents will be able to choose between two preselected species, and there is a limit of 2 trees per home. The city will approve the location selected by owners, and will coordinate the planting of the trees. The cost is \$150 per tree, with the city covering the remaining cost of purchase and installation. More information will be mailed as it becomes available.
